## About ENoP

The *European Network of Political Foundations (ENoP)* was established in 2006. The platform serves as a tool for communication and dialogue between political foundations in Europe, the EU institutions, and civil society organisations (CSOs) in the fields of democracy support, development cooperation and political dialogue. It aims at bridging the existing gap between CSOs and political actors.







The network consists of 51 member foundations and two affiliated entities, coming from 22 countries within the EU. It is open to new members provided they meet the membership criteria as laid down in the working regulations. The members are close to six party families - ALDE, ECR, EPP, Greens/EFA, GUE/NGL, S&D - represented in the European Parliament belonging to the democratic spectrum but independent in their decision making and financing of international projects.

The working structure of ENoP consists of three bodies: General Assembly (GA), Steering Committee (SC), Coordination Board and Advisory Board. The General Assembly meets once a year. The full members and substitutes of the ENoP Steering Committee meet four times per year on invitation of the Network Coordinators.

The Coordination Board currently consists of the following members: Network Coordinator, Ms. Dr. Cornelia Hoffmann/ Head of EU Programmes & Democracy at the Heinrich-Böll-Stiftung, Germany; Deputy Network Coordinator, Jakob Bec/ Acting Director at the Institut dr. Janeza Evangelista Kreka, Slovenia and Treasurer, Ms. Anne Schley, EU Project Coordinator at the Hanns-Seidel-Stiftung, Germany. The Advisory board, created back in 2015, is currently represented by: Rebecca Harms, Gudrun Kopp, Doris Pack, Wilfried Telkaemper and Jan Marinus Wiersma.

The activities of Political Foundations in the fields of democracy support and development cooperation include public campaigning and awareness building, advocacy, lobbying political institutions and decision makers in their respective home countries. The main focus, however, is reflected in the activity of ENoP's four Working Groups: "Sustainable Development", "Democracy", "The Future of Europe" and "EU Funding" as well as on the implementation of relevant projects with local partners in more than 100 developing and transition countries throughout the world. In 2016, ENoP has signed a Framework Partnership Agreement (FPA) with the European Commission, acknowledging the important role of the Network in the fields of development cooperation and democracy support; encouraging the work of political foundations in promoting pluralistic societies worldwide; combatting shrinking space of CSOs and strengthening the capacities of political parties.
